4. Public Comment.

Joseph Guevara, 206 2nd Street, stated that the issue is the trailer placed on 2nd and Ponoka Ave. is in residential zone. He wants to know why it was permitted, and a second one to be brought in later. Why is the zoning board and council allowing the trailer in residential zone, there is no zone for trailers. He talked about the zoning map and the legend, spoke of the Montana zoning regulations, and how many zoning members are to be on the board. The trailers will bring crime and drugs. The VADC erected two beautiful monuments on both ends of Town and going to trash with the trailers. The committee didn't ask him how he feels about trailers being moved into his neighborhood. He is disappointed in the council and doesn't believe the Town followed procedure

6. Law Enforcement Report

Deputy Jason Cichosz present at the Town Council meeting. Informed the Town to be on the lookout for hypodermic needles and to call if anyone finds any. Do not pick them up just call non-emergency number. Some of the highlights from February and March include: 20 citations/warnings issued, 27 traffic, 2 DUI, 2 disturbance, 4 medical emergency, 6 controlled burn, 1 suspicious vehicles, 1 phone scam, 3 assaults, 1 911 hang up, 2 civil papers served, 3 citizen assist, 2 drug calls, 1 accident, 1 citizen dispute, 1 trespassing, 1 VIN inspection, 1 welfare check, and 4 arrests.

Bozeman Green Build gave a presentation on the Town of Valier project proposal for the Lagoon.

8. Animal Ordinance.

9. Public Works Report.

The Town pumped 1,025,700 gallons of water for the month, for an average of 35,369 gallons per day. Bulk water sold 37,400 gallons for the month. The water sample was good for the month. The water levels in the wells are about average for this time of year.

Janelle Nelson gave the Town an update on gathering up questions and the needs of the community, VADC is also helping, to add to the community needs survey. Working on how to best distribute the survey, email, mail, online, ect. Going to continue working on it.
